Sub.: Electrification cost as per clause 5(1) of Schedule of Charges and Procedure 2017

Sir,

The Commission is in receipt of representation dated 24.05.2022, 17.06.2022, 21.06.2022 from DDA requesting for review of DERC letter dated 17.03.2022, wherein the electrification cost as per Clause 5(1) of Schedule of Charges and Procedure order dated 31.08.2017 under DERC (Supply Code and Performance Standards) Regulations, 2017 has been clarified.

2. In order to examine the matter the Commission has sought the additional information from the Distribution Licensees regarding the electrification cost.

3. The Commission observed that Clause 6(5) of DERC order dated 31.08.2017 stipulates that the cost incurred for acquisition of space including the annual license fee, if any, shall be borne by the developer or the applicant.

4. Accordingly, based on the representation of DDA, submissions made by the Distribution Licensee and the provisions of DERC Schedule of Charges and Procedure Order dated 31.08.2017, it is clarified that in addition to payment of Rs.75 lakhs per MVA towards EHT cost as per provisions of Order dated

31.08.2017, the additional cost towards land (where land for grid substation has not been provided free of cost) shall be levied as under:

- i. Payment of Annual License Fee by DDA as per provisions of Clause 6(5) of DERC Order dated 31.08.2017;

OR

- ii. Payment of Rs. 14 lacs per MVA towards land cost where land is allotted by DDA through GoNCTD to the distribution licensee on payment of annual lease charges.

5. The letter supersedes the letter dated 17.03.2022 for payment of electrification cost for EHT charges by DDA.
