F.3(620)/Tariff-Engg./DERC/2020-21/6846- The Delhi Electricity Regulatory Commission, in exercise of the power conferred under Guideline 17 of *Delhi Electricity Regulatory Commission (Group Net Metering and Virtual Net Metering for Renewable Energy) Guidelines, 2019* and all other powers enabling it in this behalf and after previous publication, hereby amend the following Guideline in Delhi Electricity Regulatory Commission (Group Net Metering and Virtual Net Metering for Renewable Energy) Guidelines, 2019 (hereinafter referred to as “the Principal Guidelines”):

**1.0 Short Title and Commencement:**

- (1) These Guidelines may be called the Delhi Electricity Regulatory Commission (Group Net Metering and Virtual Net Metering for Renewable Energy) (Third Amendment) Guidelines, 2021.
- (2) These Guidelines shall come into effect from the date of uploading on DERC website.

**2.0 Amendment of Guidelines 3 (6) of Principal Guidelines:**

In Guidelines 3(6) (Applicability of VNM), the following shall be substituted as:-

*“3 (6) The Distribution Licensees shall facilitate and bear the capital expenditure on account of Service Line cum Development (SLD) and network augmentation towards Renewable Energy projects and the same shall be pass through in Aggregate Revenue Requirement (ARR) for the schemes under VNM and GNM mode.*

*Provided that such waiver of SLD will be effective till additional capacity doesn't exceed 75 MW, 50 MW, 30 MW and 10 MW for BRPL, TPDDL, BYPL and NDMC respectively for projects under Virtual Net Metering and Group Net Metering in each Distribution Licensee.*

*Provided further that Distribution Licensees shall submit quarterly progress reports for Net Metering, Group Net Metering and Virtual Net Metering to the Commission and EE&RM, DoP, GoNCTD.”*

**Instead of**

*“(6) The distribution licensee shall facilitate and bear the capital expenditure on account of Service Line cum Development (SLD) and network augmentation towards Renewable Energy projects registered under Mukhya Mantri Kisaan Aay Badhotari Yojna and the same shall be pass through in Aggregate Revenue Requirement (ARR) for the schemes implemented upto 31st March 2022 subject to prudence check by the Commission.”*
