Objections / Response to Tata Power - DDL's Appeal No. 301 of 2015 filed before the Hon'ble Appellate Tribunal for Electricity against various findings contained in DERC's Tariff Order dated 29.09.2015 (for True up of FY 2013-14, Aggregate Revenue Requirement and Distribution tariff (Wheeling and Retail Supply) for FY 2015-16

1. Tata Power Delhi Distribution Limited (**TPDDL**), formerly known as North Delhi Power Limited has filed an Appeal before Hon'ble Appellate Tribunal for Electricity ("**ATE**") challenging the various findings contained in the Tariff Order dated 29.09.2015 (**for True up of FY 2013-14, Aggregate Revenue Requirement and Distribution tariff (Wheeling and Retail Supply) for FY 2015-16**) passed by the Delhi Electricity Regulatory Commission. Hon'ble ATE has admitted the said Appeal and *vide* Order dated 16.03.2016 directed Tata Power-DDL to publish a Public Notice to inform the respondents/public of filing of the said Appeal and also to invite objections and response, if any against the said Appeal. The said Appeal is now posted for hearing before Hon'ble ATE on 07.04.2016 at the Appellate Tribunal for Electricity, 7th Floor, Core IV, SCOPE Complex, Lodhi Road, New Delhi 110003.

The said objections / response should be supported by an affidavit in the notified format (draft available with copy of the Appeal) and should carry the full name, postal address, consumer no. and e-mail address, if any, of the sender. Should the objector wish to be heard in person subject to the approval of the Hon'ble ATE, may appear before the Hon'ble ATE on 07.04.2016 for which no separate notice shall be issued.
