Subject: Status of Net Metering, Group Net Metering and Virtual Net Metering for Q2 FY 2025-26 of Tata Power-DDL.

Dear Sir,

We write in reference to the directions issued by the Hon'ble Commission on the above cited subject. Relevant Clause of the Delhi Electricity Regulatory Commission (Group Net Metering and Virtual Net Metering for Renewable Energy) (Third Amendment) Guidelines, 2021 issued on 28.09.2021, wherein Hon'ble Commission has directed the Distribution Licensees to appraise it of the status of Net Metering, Group Net Metering and Virtual Net Metering to the Commission on quarterly basis, has been reproduced below for ready reference:

"3 (6).....Provided further that Distribution Licensees shall submit quarterly progress reports for Net Metering, Group Net Metering and Virtual Net Metering to the Commission and EE&RM, DoP, GoNCTD."

Accordingly, the status of Q2 FY 2025-26 is as given below.
