Subject: Submission of details of electrical accidents and action taken in line with DERC (Compensation to Victims of Electrical Accidents) Regulations, 2024 for the month of Jan 2025.

Dear Sir,

The Hon'ble Commission had notified the DERC (Compensation to Victims of Electrical Accidents) Regulations, 2024 which was published in the official gazette on 26.07.2024. With their publication in the official gazette, these Regulations have come into force from 26.07.2024 as provided in these Regulations.

Further, these Regulations provide for submission to the Hon'ble Commission by 15<sup>th</sup> of every succeeding month, the details of electrical accidents occurring within the respective jurisdiction of the distribution licensee and action taken thereon in accordance with these Regulations. Same is reproduced below for ready reference:

## "18. Information to the Commission: -

The generating company or transmission licensee or distribution licensee shall submit to the Commission by 15th of every succeeding month, the details of electrical accidents occurring within their respective jurisdiction and action taken thereon in accordance with these Regulations."

Accordingly, Tata Power-DDL is submitting the report, enclosed herewith as **Annexure-1**, for the month of Dec 2024 i.e. 01.01.2025 to 31.01.2025.

We hope the Hon'ble Commission would find the above in order.
